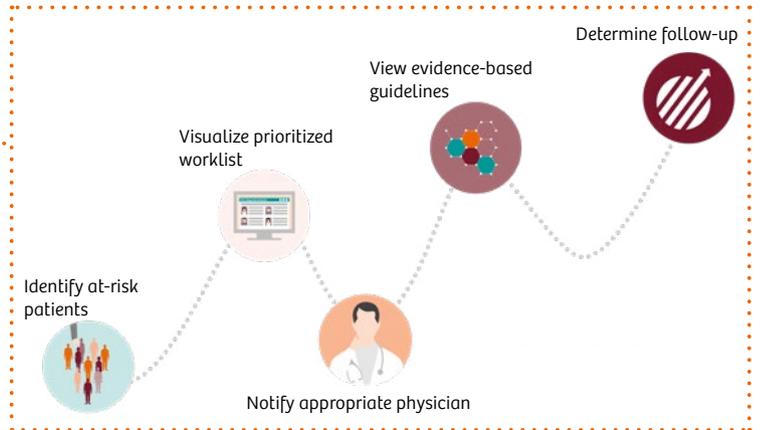


Have the information you need at a glance
